Information on the processing of personal data pursuant to art. 13-14 EU Reg. 2016/679

Interested parties: customers / suppliers.

Euro Cargo Express Srl, as Data Controller of your personal data, pursuant to and for the effects of EU Reg. 2016/679, hereafter referred to as 'GDPR', hereby informs you that the aforementioned legislation provides for the protection of data subjects respect to the processing of personal data and that this treatment will be based on principles of correctness, lawfulness, transparency and protection of your privacy and your rights.

Your personal data will be processed in accordance with the legislative provisions of the aforementioned law and the confidentiality obligations laid down therein.

The purpose and legal basis on the processing of personal data: in particular, your data will be processed for the following purposes in compliance with legislative obligations:

- Compliance obligations required by law in the field of taxation and accounting;
- of obligations established by the laws in force.

Your data will also be used for the following purposes related to the execution of measures related to contractual or pre-contractual obligations:

- management of suppliers;
- planning of activities;
- historical orders of supplies.

Method of treatment. Your personal data may be processed in the following ways:

Communication: your data will be communicated exclusively to competent and duly appointed persons for the performance of the services necessary for the correct management of the relationship, with a guarantee of protection of the rights of the interested party.

Your data will be processed only by personnel expressly authorized by the Owner and, in particular, by the following categories of employees:

- Freight Forwarders or agents;
- Purchasing department;
- Administration office.

Your data may be communicated to third parties duly appointed responsible for processing Personal Data, whose list will be available at the simple request of the interested party, in particular to:

- banks and credit institutions;
- consultants and freelancers, also in associated form;
- in the context of public and / or private subjects for whom the communication of data is mandatory or necessary in compliance with legal obligations or in any case when it is functional for the administration and communication between the parties;
- Freight Forwarders, Agents, Trucking company, post offices, companies of freelancers in the logistics industry.

Disclosure: Your personal data will not be disclosed in any way.

Conservation Period. Please note that, in compliance with the principles of lawfulness, purpose limitation and data minimization, pursuant to art. 5 of the GDPR, the retention period of your personal data is:

- established for a period of time not exceeding the achievement of the purposes for which they are collected and processed for the execution and completion of the contractual purposes;
- established for a period of time that does not exceed the services provided;
- established for a period of time not exceeding the achievement of the purposes for which they are collected and processed and in compliance with the mandatory time limits prescribed by law.

You have the right to obtain from the holder, the cancellation (right to be forgotten), limitation, updating, correction, portability, opposition to the processing of personal data concerning you, as well as in general can exercise all the rights provided by articles 15, 16, 17, 18, 19, 20, 21, 22 of the GDPR.

EU Reg. 2016/679: Articles 15, 16, 17, 18, 19, 20, 21, 22 - Rights of the interested party

1. The interested party has the right to obtain confirmation of the existence or not of personal data concerning the requester, even if not yet registered, and their personal data communication in an intelligible form.
2. The interested party has the right to obtain the following information:
 - a. the origin of personal data;
 - b. the purposes and methods of processing the personal data;
 - c. the logic applied in case of treatment handled with the aid of electronic instruments;
 - d. the identification details of the holder, of the responsible and of the designated representative according to article 5, paragraph 2;
 - e. the people or categories of people or entity to whom the personal data may be communicated or who can learn about them as appointed representative in the territory of the State, managers or agents.
3. The interested party has the right to obtain:
 - a. updating, rectification or, when interested, integration of data;
 - b. the cancellation, transformation into anonymous form or blocking of data processed unlawfully, including data whose retention is unnecessary for the purposes for which the data were collected or subsequently processed;
 - c. the attestation that the operations referred to in letters a) and b) have been brought to the attention, also with regard to their content, of those to whom the data have been communicated or disseminated, except in the case in which this fulfillment is impossible or involves a use of measures manifestly disproportionate to the protected right;
 - d. data portability.
4. The interested party has the right to object, in whole or in part:
 - a. for legitimate reasons, the processing of personal data concerning them, even if pertinent to the purpose of the collection;
 - b. to the processing of personal data concerning him for the purpose of sending advertising or direct sales material or for carrying out market research or commercial communication
